\_\_\_\_ Insurance and Driver's License-Each vehicle that enters the parade line-up area must have liability insurance, a licensed driver (copies of insurance and driver's license of driver must be submitted with this application).

\_\_\_\_ Indemnify and Hold Harmless-All applicants are held responsible for any and all acts on their part, or the part of their agents, volunteers and/or employees that may result in the injury or damage to themselves, their agents, volunteers, employees, and/or third parties. Parade applicant agrees to indemnify Gay Pride SA and its volunteers against any and all claims arising out of any such acts.

\_\_\_\_ Drugs and Alcohol-Drugs and alcoholic beverages are strictly prohibited in the parade staging area or anywhere along the parade route. Participants found to have drugs or alcohol in their possession will be removed from the parade. Please discourage your participants from consuming drugs or alcohol prior to or during the parade.

\_\_\_\_ Throwing from your unit-Due to the danger of physical injury, please refrain from throwing ANYTHING from your moving unit. Please do NOT encourage viewers to come anywhere near your moving unit.  
\*\*If you intend to pass anything out, please have someone on the ground near your vehicle to pass items out.

\_\_\_\_ Overcrowded Vehicles-Gay Pride SA reserves the right to reduce the number of individuals that happen to be riding on moving vehicles. Any moving unit which is determined to be overcrowded to such an extent that the unit may break down or cause injury to participants, volunteers, or spectators will be asked to make a reduction.

\_\_\_\_ Signs or Banners-In order to facilitate parade announcements, a sign or banner providing the name of the organization/business must precede each entry participating in the parade or the name prominently displayed on the vehicle where it will be most visible to the announcers.

\_\_\_\_ Step-Off- All units must be ready to move on cue into the parade or the next unit will proceed. The delayed unit will be asked to wait to be included at the next most convenient time.

\_\_\_\_ Flow of Parade-All entries are required to maintain a continuous forward motion during the parade. Parade monitors will assist in maintaining a consistent flow of traffic for the duration of the parade.

\_\_\_\_ Animal Units-all animal units must provide clean-up for all wastes created by their animals. Wastes cannot be left in the street.

\_\_\_\_ Parade Liason-All participants are asked to provide contact information for a parade liason who will attend the parade orientation meeting and will facilitate the movement of all vehicles and/or marchers in their unit. Participants who do not provide a parade liason will not be allowed to participate in the parade.

\_\_\_\_ All entries are required to clean-up the staging area around their unit.

I have read, understand, and agree to the above procedures and guidelines. I also understand that any violation of any regulation is cause for removal from parade.
